
Dear Mr. Reynolds:

On January 30, 2009 S.C. Johnson & Son, Inc. (SCJ) submitted a notification to the Agency to add label language to comply with the Container Rule. The Agency replied on March 31, 2009 that the notification was received, reviewed and would be placed in Agency records.

It has recently come to our attention that some past instruction from the Agency to update the Storage and Disposal section (initial Agency request made 3/9/04 and confirmed as acceptable 4/4/05) was not incorporated into the label submitted March 31, 2009. The specific changes needed are to add a "Storage and Disposal" heading and to place a box around the entire section to clearly distinguish it from other Directions for Use.

SCJ would like to consolidate all approved label elements into one document. Since this consolidation involves no real changes or additions, we feel this certainly would qualify as a notification under PR Notice 98-10, II, N - *Labeling Notifications, Other Revisions*. We would also like to take the opportunity to incorporate the alternate brand name, **OFF! Botanicals Insect Repellent**, submitted to the Agency on May 15, 2000. We have added "[EPA base file name]" following the master name of record, OFF! Botanicals 2.

Although none of what is described above is a true addition, I have marked the areas in **bold italics** for ease of reference. In accordance with PR Notice 98-10 we have included a completed Application for Registration and one (1) copy of the subject label.


