On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act.

Registration is in no way to be construed as an endorsement or recommendation of this product by the Agency. In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. The acceptance of any name in connection with the registration of a product under this Act is not to be construed as giving the registrant a right to exclusive use of the name or to its use if it has been covered by others.

This product is conditionally registered in accordance with FIFRA sec. 3(c)(7)(A) provided you:

1. Submit and/or cite all data required for registration/reregistration of your product under FIFRA sec. 3(c)(5) when the Agency requires all registrants of similar products to submit such data; and submit acceptable responses required for reregistration of your product under FIFRA section 4.
2. Make the following label changes before you release the product for shipment:
 - a) Revise the EPA Registration Number to read "EPA Reg. No. 4822-555".
3. **Marketing Claims:**
 - a) Remove West Nile virus and other mosquito-borne disease claims from the label. The current efficacy database does not support these claims. Product specific data or citation of data from a substantially similar product are required.
 - b) Remove "Effective DEET alternative" from the label.

c) Qualify the use of the claim "long lasting protection" with the protection time of 8 hours.

4. First Aid: Remove the statement "Skin" as the product is category IV for dermal toxicity and skin irritation. It is not a sensitizer. Note that only statements consistent with the Label Review Manual should be used in this section of the label.

5. Precautionary Statements.

a. Add a referral statement to the front panel of the label, "Refer to back/side panel for additional precautions."

Revise the precautionary statements as follows:

b. HAZARDS TO HUMANS- WARNING:

"Causes substantial but temporary eye injury. Do not get in eyes. Wash thoroughly with soap and water after handling, returning indoors, and before eating, drinking, chewing gum or using tobacco. Discontinue use and consult a doctor if irritation or rash occurs."

c. Add an emergency response telephone number or make reference to calling a poison control center for emergencies.

6. Revise the "Directions for Use" as follows:

a. Change: "For continued insect protection, reapply as effectiveness diminishes, but do not exceed 2 applications per day." to "Reapply every eight hours. Do not apply more than two times per day."

7. Refer to PR Notice 2007-4 "Standards for Pesticide Containers and Containment" and revise your label accordingly.

8. Confidential Statements of Formula.

a. The basic Confidential Statement of Formula (CSF), dated October 30, 2006 is acceptable and is the basic CSF of record.

b. The alternate CSFs (Alt 1, 2 and 3) dated June 6, 2007 are not acceptable because EPA does not have information on the composition of one of the inert ingredients. Please see "Appendix A" of the attached product chemistry review for more information.


9. Storage Stability Data. Submit the results of one year storage stability (830.6317) and corrosion characteristics (830.6320) to the Agency on completion. It is recommended that the observations be made at 0, 3, 6, 9, & 12 month intervals. The results must be submitted in a hard copy and an electronic format is also requested.

Please submit three (3) copies of your final printed labeling before releasing the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing amended labeling constitutes acceptance of these conditions.
