Revise the following marketing claims:</p> <ol style="list-style-type: none"> <li>Revise "Repels mosquitoes which may carry WEST NILE VIRUS" to: "Repels mosquitoes that may transmit West Nile Virus."</li> <li>Revise "Repels mosquitoes which may carry diseases such as ENCEPHALITIS and DENGUE" to: "Repels mosquitoes that may transmit Encephalitis and Dengue Fever."</li> <li>Revise "Repels deer ticks which may carry Lyme Disease" to: "Repels deer ticks which may transmit Lyme Disease"</li> <li>Revise "Repels mosquitoes, chiggers, ticks, biting flies, deerflies, stable flies, blackflies, gnats and fleas on exposed skin surfaces, deer ticks (vector Lyme disease)" to: "Repels mosquitoes, chiggers, ticks, biting flies, deerflies, stable flies, blackflies, gnats and fleas on exposed skin surfaces, and deer ticks (that may transmit Lyme disease)."</li> </ol>  |   |   |

- 2. Within the Hazards to Humans section, revise as follows:
  - a. Remove the following statements: "Do not get in eyes. Instruct older children in the proper use of this product. Avoid contact with eyes, lips, cuts, excessively sunburned or damaged skin."<sup>1</sup>
  - b. Add the following statement to the end: "Wash hands with soap and water after handling."

- 3. Within the Directions for Use section, revise as follows:
  - a. Directly below the FIFRA required statement "It is a violation of Federal law to use this product in a manner inconsistent with its labeling" insert the following statements:

For Outdoor Use Only. Do not spray in enclosed areas. Never use repellents over cuts, wounds, or irritated skin. Do not apply near eyes and mouth, and apply sparingly around ears. When using sprays, do not spray directly into face; spray on hands first and then apply to face. Do not allow children to handle this product, and do not apply to children's hands. When using on children, apply to your own hands and then put it on the child. Apply only to exposed skin and/or clothing (as directed on the product label). Do not use under clothing. Use just enough repellent to cover exposed skin and/or clothing. Heavy application and saturation is unnecessary for effectiveness; if biting insects do not respond to a thin film of repellent, apply a bit more. After returning indoors, wash treated skin with soap and water or bathe. This is particularly important when repellents are used repeatedly in a day or on consecutive days. Also, wash treated clothing before wearing it again. **Use of this product may cause skin reactions in rare cases. If you suspect a reaction to this product, discontinue use, wash treated skin, and call your local poison control center. If you go to a doctor, take this product with you.**

- b. Move all non-precautionary statements to a new section as follows:
  - "Application Instructions:**

To repel insects listed on the front panel, hold can at least 12 inches away. Point opening in desired direction towards skin and outer clothing surfaces, press top to spray. For chiggers, also apply to shoe tops, socks and around openings of clothing.

Do not apply to or near plastics, leather, acetate rayon, spandex or colored fabrics other than nylon. If applying to clothing, spray lightly. Avoid spraying on or near nail polish, watch crystals, eyeglass frames, furniture, and painted or varnished surfaces, including bicycles and automobiles. Excess spray drifting onto grass or foliage will cause discoloration, but will not otherwise damage the plant.

- 4. Revise the Storage and Disposal Section as follows:

**"Storage and Disposal**  
**Do Not Puncture or Incinerate**  
**Pesticide Storage:** Store in a cool dry place away from heat or open flame.  
**Pesticide Disposal:** If empty: Place in trash or offer for recycling if available.



- 5. To be eligible for reregistration, aerosol and pump spray formulations must be packaged in containers utilizing a concave trigger to help aim product or other comparable mechanism that will ensure that the product will not be inadvertently sprayed in the eyes.
- 6. The Agency is in the process of developing and improving the current Efficacy Assessment Guidelines for repellent products. The Agency intends to defer the determination of any related efficacy data requirements supporting the claims that may appear on this label until these Efficacy Assessment Guidelines are complete. When the guidelines are finalized, the Agency expects to issue a Data Call-In to address the revised guidelines to all registrants with registrations for personal repellent products that have not previously submitted efficacy data sufficiently consistent with the revised guidelines.
