The proposed amendment to the registration for the product cited above under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended revising the label in accordance with PR Notices 2001-1 and 2001-6 is acceptable subject to the comments listed below:

1) Your supplier of deet is no longer claiming that their product is 100% active. Morflex is now claiming that their product is 98.11% active. Therefore, you must change the ingredients statement on the label for your product to read:

ACTIVE INGREDIENT	
DEET.....	98.11%
OTHER INGREDIENTS.....	1.89%

2) Add a Precautionary Statement to read as follows:

Precautionary Statements


Hazards To Humans And Domestic Animals

3) Submit a revised Confidential Statement Of Formula(CSF). The latest CSF for this product is dated May 11, 1991 and must be revised in light of your supplier's new declaration of active for their product.
