Your Submission Dated January 19, 2010**

Dear Ms. Killoren:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable with the following label revision provision(s):

General Comment(s):

1. Delete all text throughout the label marked with "strikethrough."

Optional Marketing Claims section comment(s):

2. Within optional marketing claim #1, replace the words "Keeps off" with the word "Repels."
3. Delete optional marketing claim #6, since DEET in itself does have a scent. Alternatively, optional marketing claim #6 can be revised to read "Low Odor Formula," similar to the comparison product.
4. Revise optional marketing claim #17 to read "Up to 10 hours of protection."

First Aid Statement section comment(s):

5. Insert the following text as a 2nd sentence within the **HOT LINE NUMBER** subsection: "For additional information on this product (including health concerns, medical emergencies or pesticide incidents), you may call 1-800-xxx-xxxx."¹

Precautionary Statements, Hazards to Humans subsection comment(s):

6. Within the existing 6th sentence, insert the word "thoroughly" immediately preceding the word "before."

Directions for Use section comment(s):

7. Relocate the line of text that reads "**READ AND FOLLOW ALL DIRECTIONS AND PRECAUTIONS ON THIS PRODUCT LABEL**" to appear immediately following the statement "**It is a violation of Federal law ...**"
8. Revise the statement "**General Precautions and Restrictions**" to read "**Use Restrictions and Precautions.**"
9. Revise the 2nd sentence of the 1st paragraph to read "If used on the face, spray on hands first and then apply sparingly and avoid eyes. Do not spray directly onto face."

¹ Please note that the "1-800-xxx-xxxx" telephone number listed must be available twenty-four (24) hours per day, seven (7) days per week for answering and responding to any medical emergencies or health concerns.

Directions for Use section comment(s), continued:

- 10. Within the 3rd sentence of the 1st paragraph, replace the words "Never use repellent" with the words "Do not apply."
- 11. Revise the 7th sentence of the 1st paragraph to read "Avoid over-application of this product. If biting insects do not respond to a thin film of repellent, apply a bit more."
- 12. Revise the 13th, 14th and 15th sentences of the 1st paragraph to read "Use of this product may cause skin reactions in rare cases. If you suspect a reaction to this product, discontinue use, wash treated skin, and call your local poison control center. If you go to a doctor, take this repellent product with you."


Storage and Disposal section comment(s):

- 13. Replace the existing "**PESTICIDE STORAGE:**" subsection with "**PESTICIDE STORAGE:** Keep this product in its tightly closed original container, when not in use. Store in a cool, dry (preferably locked) area that is inaccessible to children and animals."
- 14. Replace the existing "**CONTAINER DISPOSAL:**" subsection with "**CONTAINER DISPOSAL: If empty:** Do not reuse this container. Offer for recycling if available. **If partly filled:** Call your local solid waste agency for disposal instructions. Never place unused product down any indoor or outdoor drain."


